3 Sector(s) and area(s) of specialization

Provision of protection services to individuals in vulnerable situations (at-risk groups among host, migrants communities).

4 Issuing Agency

International Organization for Migration (IOM) in Egypt (Cairo) is looking for a strategic partnership with a non-governmental organization (national or international) that has substantial nationwide capacity (including warehouses, human resources, experience working with vulnerable migrants) in Egypt.

5 Rationale

The overall IOM Protection portfolio includes multifaceted approach to support vulnerable migrants and hosting communities, strengthen the capacity of non-governmental (NGO) and community-based organizations (CBO), facilitate migration governance and partnership with the government.

To support IOM to implement its protection and prevention program activities, IOM builds a roster of interested and dynamic NGOs and CBOs with relevant experience and capacity in the protection area to pre-assess and refer vulnerable cases to IOM, provide required direct and reintegration assistance to build economic self-sufficiency, social stability, and psychosocial wellbeing of migrants and hosting communities in coordination with local authorities and community leaders.

The program will be implemented in the time frame of 2024 – 2025 in partnership with preselected INGOs/NGOs and CBOs given the availability of confirmed funding. The implementing partner should be a duly registered local NGO with at least five years' experience in carrying out assistance services with vulnerable migrants (and migrant victims of trafficking) in Egypt;

The implementing partner should have previously successfully managed international donor-funded projects, proof of previous or current work with migrant communities in Egypt,

capacity to partially prefinance project, be fluent in English and Arabic.

Expected Results

Based on the objectives and priorities of program activities and individual capacity of the interested organization the following results are expected from implementing partners (IPs):

- Capacity building of the hosting communities and local authorities to listen and preassess the protection risks for refugees and asylum seekers, victims of trafficking in persons (TIP) & gender-based violence (GBV), unaccompanied minors (UAMs), people living with disabilities (PLwD), etc. and refer to IOM for eligibility screening;
- Capacity building of migrant and refugee community leaders, health volunteers and other CBOs to sensitize communities on their rights, availability of services, risk communication, and community engagement.
- Collect and process data in Kobo on vulnerable cases and service roadmaps;
- Distribution of food and non-food items to IOM's beneficiaries;
- Income-generating orientation and support;
- Carry out the catch up clubs for students who have had their education interrupted by the conflict, including providing essential education materials.
- Conduct outreach and host community cohesion events with children from migrant and host communities.

7 Indicative Budget

The budget requested from IOM should not exceed 30,000 USD for the whole period of partnership of which operational costs should be not less than 75%.

A detailed description must be provided on how the requirements specified in the Call for Expression of Interest (CEI) issued by IOM will be matched by the capabilities, experience, knowledge and expertise of the Implementing Partners.

The Application must be submitted in the English language and in the format prescribed by IOM within the CEI. All required information must be provided, responding clearly and concisely to all the points set out. Any application which does not fully and comprehensively address this CEI requirements may be rejected.

The Application document should comprise of the following:

- Cover Letter;
- Duly accomplished application documentation as outlined within the CEI;
- Any other relevant documents.

Applications may be modified or withdrawn prior to the closing time specified in this CEI.

Applications shall not be modified or withdrawn after the deadline.

The Implementing partner shall bear all costs associated with the preparation and submission of the Application and IOM will not in any case be responsible and liable for the costs incurred.

IOM at no occasion will ask an application fee from Implementing Partners.
