Terms of reference (TOR)

A. Project Title: "Youth Mediterranean (Y-med)" project.

B. Project Description

Promoting the linkage between migration and development and reinforcing the conditions that make this linkage possible have been among IOM priorities for several years now.

Migrations create a connection between different countries and migrants link different experiences, turning themselves into actors of development for the countries they connect.

The role of the private sector in the Migration and Development initiatives is internationally recognized as well as mentioned in the 2030 Agenda for Sustainable Development and its related goals (SDGs) and in the IOM Skills-based Migration and Partnerships guidelines. In particular, with relation to circular migration schemes, companies can contribute to the sustainability of M&D initiatives and to the achievement of the SDGs, by offering training and job opportunities for young people, triggering transnational development processes through the circulation of knowledge and skills.

Skills Mobility Partnerships (SMPs) promote skills development through migration to the benefit not only of the country of destination, but also of the country of origin and of migrants themselves. This is done through an accurate assessment of skills and human resources needs in both countries of origin and destination, through the sharing of experiences and engagement in training and skills development between countries and through mutual recognition of competences and certifications. In SMPs all stakeholders actively contribute to the circulation and to the development of skills to foster development for all the involved parties.

Within this framework, the Italian Ministry of Foreign Affairs and International Cooperation, through the Italian Voluntary Contribution, supports IOM initiatives to facilitate skills circulation in the Mediterranean through the Y-med project. The aim of the project is to pave the way for future international six-months internship schemes from Egypt, Morocco, Libya and Tunisia to Italy, by engaging public and private stakeholders and by empowering selected universities and vocational training centers to integrate international internship schemes to Italy into their service provision, within the framework of SMPs.

C. Scope of work

As Y-med focuses on benefiting both country of origin and country of destination and limit risks of brain drain; one of the main goals of the project is to support with the job placement of interns upon their return from their internships in Italy.

In that scope, IOM will provide 10 fresh graduates with the opportunity to participate in a six-months internship in Italian companies in Italy, in the fields of ICT and Mechanical Engineering and will need a service provider to support in identifying priority areas for upskilling Egyptian youths and providing the interns with relevant jobs after their return to Egypt.



D. Institutional Arrangement

The service provider will be required to coordinate directly with the Y-med Project Assistant at IOM, this includes any reports, approvals, and obtaining certificate of acceptance of output.

E. Duration of Work

The internships are foreseen to take place from November 2024 until April 2025, while the requested support for the job placement activities is expected to take place between February 2025 and April

F. Qualifications of the Successful Service Provider at Various Levels

The service provider should have a minimum of five years of experience in the field of online job recruitment, specifically in the ICT and Mechanical Engineering sectors.

G. Scope of Proposal Price and Schedule of Payments

The contract price is a fixed output-based price regardless of the specific duration.
